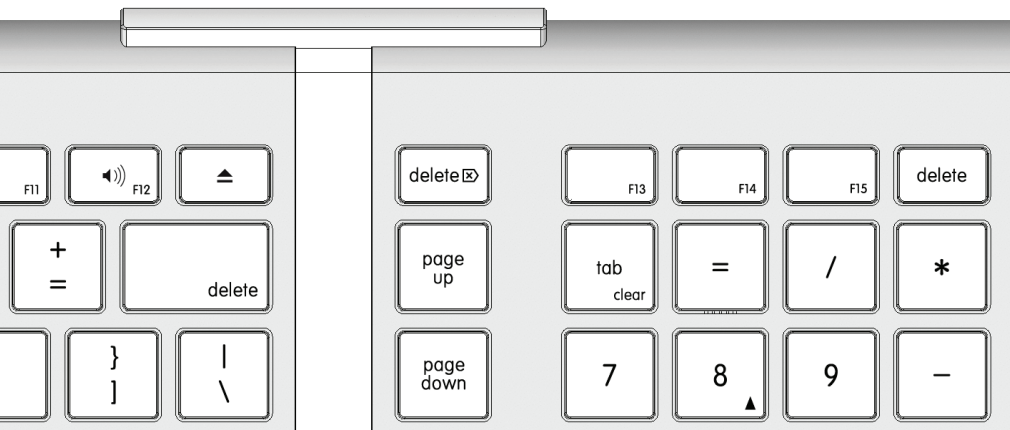




Apple Wireless Keyboard can be connected using the supplied bracket

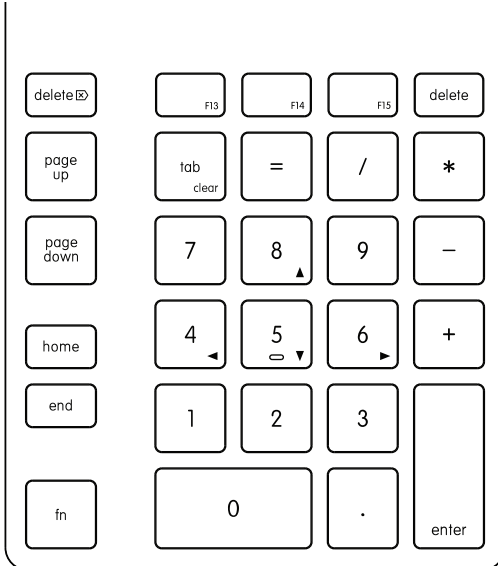


LEDs:
